18. GOLF CARTS, USE FOR GOLF PURPOSES 2

- 18.1 Drivers of golf carts are required to be at least age 16 and have a valid automobile driver's license.
- 18.2 Use of a golf cart is at the risk of the user.
- 18.3 Use of a golf cart is limited to two persons and two golf bags, and no more than two golf carts per group unless approved by the golf shop.
- 18.4 A member who qualifies for a handicap flag is the only one entitled to use that flag. Additionally, when weather dictates "cart paths only," carts with handicap flags must comply. The cart access restrictions in this section and Section 18.5, as well as the golf course access restrictions in Section 17, will be strictly enforced; and members who violate them may be subject to appropriate disciplinary action including the suspension of membership privileges and/or monetary penalty for damage (see Rule 9.1) as determined by the Club.

18.5 Golf Cart Usage Rules

- All four wheels need to stay on the golf cart path whenever possible.
- Carts may be driven and parked as close as 20 yards from the front fringe of a green, but may <u>never</u> be driven between greenside bunkers and a green, nor on the sides or behind the greens.
- A member who qualifies for a handicap flag is the only one entitled to use that flag. The flag must be renewed every five years.³
- Carts with handicap flags may be driven 10 yards to the front, side and behind the green where it is level and safe to do so (i.e. no steep slope). Carts with handicap flags may <u>never</u> be driven between greenside bunkers and a green.
- When weather dictates "cart paths only," all carts, including carts with handicap flags must comply. More rules affecting golf carts may be found in section 18 of Club Rules.
- All par 3's are cart path only except for handicap flag holders.³
- These rules will be strictly enforced; and members who violate them will be subject to appropriate disciplinary action including the suspension of Golf privileges and/or monetary penalty for damage as determined by the Club.
- The Superintendent will dictate where carts are to be operated, fairways, rough and/or cart paths.
- 18.6 The use of golf carts is mandatory for all players until 3:30 p.m. or as determined by the General Manager. After 3:30 p.m. walking may be permitted.
- All members who own golf carts are required to execute a private golf cart agreement, pay the required annual trail fees, comply with the appearance standards established by the Club and comply with the rules established by the Club for use of privately owned golf carts. A separate golf cart agreement is available at a reduced fee for those members who do not use a golf cart on the golf course.
- 18.8 All privately owned carts shall undergo an annual inspection and have a registration decal in place by January 31 of each year.
- 18.9 Players shall register in the Golf Shop before using Club-owned golf carts.
- 18.10 Members are permitted to use Club-owned golf carts for golf play only.
- 18.11 Golf carts may be equipped with a cooler consistent with that sold in the Golf Shop and attached to the golf cart as prescribed by the professional golf staff.
